Proposal


The City of Toronto Planning Division has received an application to amend the Official Plan and Zoning By-law for the property at 510-528 Yonge Street & 7 Breadalbane Street to permit the redevelopment of the site with a 59-storey building (196.9 metres including the mechanical penthouse) containing 500 dwelling units (including 19 rental replacement units), 519.5 square metres of retail, and a 464.5 square metre community hub space. An off-site parkland dedication of approximately 415 square metres is proposed on the lands municipally known as 431 Yonge Street.
